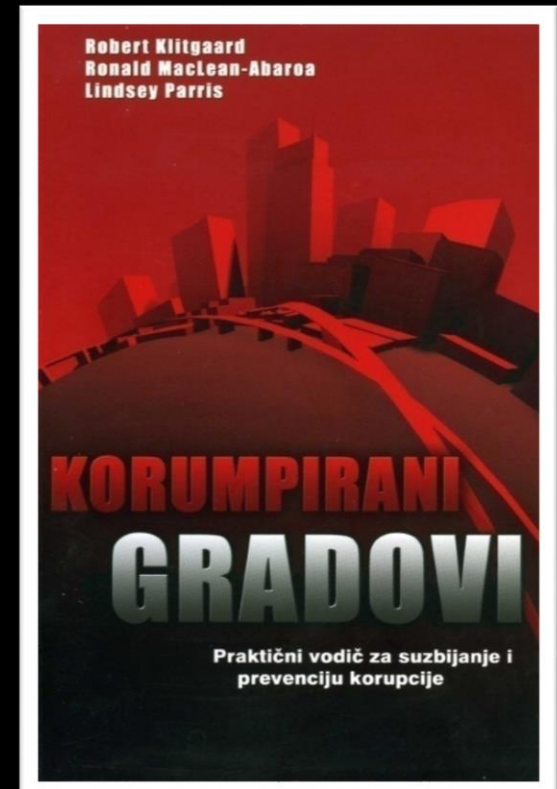
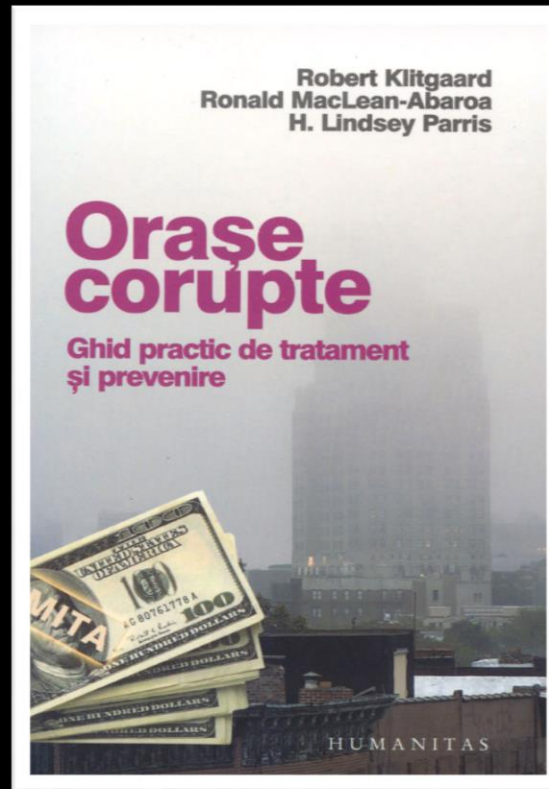
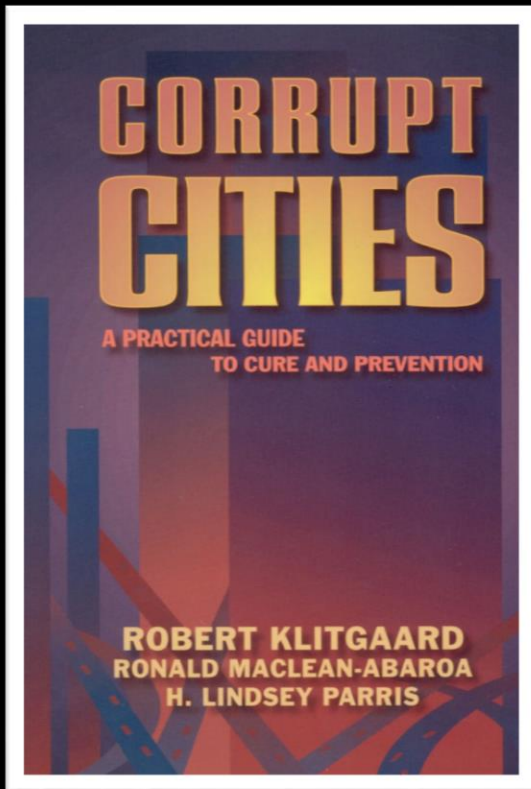
Support for in-country Anticorruption Interventions at local level

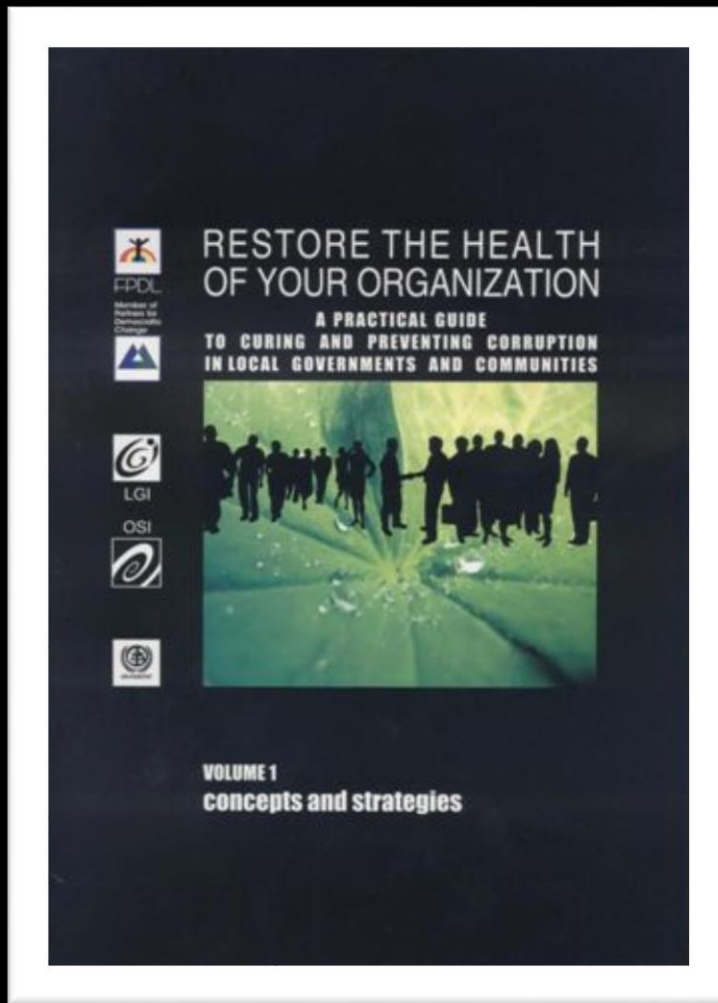

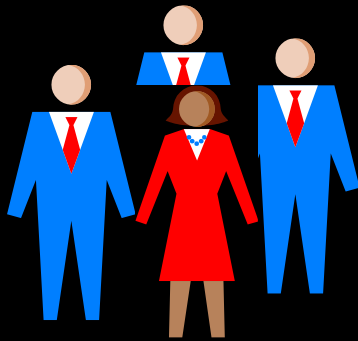
